- 3) The Second Party will provide the necessary infrastructure and technical assistance as a need base to the students by conducting Online or Offline Mode of Instruction.


Responsibilities:

- 5) Upon successful completion of the Programme, the First Party shall facilitate the issuance of Participation Certificates & Books of Personality Development to the meritorious students.


Terms and Conditions:

- 5) This MoU become effective from the date of execution as mentioned above.


